## COMMITTEE MEETING MINUTES

The House Standing Committee on Communications and Technology was called to order by Chair Hoitenga.

The Chair laid HB 4266 and HB 5266 before the committee:

HB 4266 (Rep. Cole) A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," (MCL 600.101 to 600.9947) by adding section 2979.

HB 5266 (Rep. Cole) A bill to amend 2008 PA 167, entitled "Electric cooperative member-regulation act," (MCL 460.31 to 460.39) by adding sections 8a and 8b.

Representative Cole testified in support of HB 4266.
