SB 0294 (Sen. Zorn) A bill to amend 1972 PA 230, entitled "Stille-DeRossett-Hale single state construction code act,"(MCL 125.1501 to 125.1531) by adding section 13h.

HB 4162 (Rep. Reilly) A bill to amend 1976 PA 451, entitled "The revised school code, "by amending section 1279g (MCL 380.1279g), as amended by 2016 PA 170, and by adding section 1279i.

Representative Wentworth offered the following amendments to HB 4162:

1. Amend page 9, line 16, after "**1279I.**" by inserting: "**(1)**".
2. Amend page 9, line 20, after "**DECISIONS.**" by striking out the balance of the line through "**SECTION.**" on line 22.
3. Amend page 9, following line 22, by inserting:
"(2) THE BOARD OF A ACHOOOL DISTRICT OR THE BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY MAY PROVIDE PUPILS WITH AN OPPORTUNITY TO TAJE AN ASSESSMENT DESCRIBED UNDER SUBSECTION (1).
"(3) THE LEGISLATURE SHALL APPROPRIATE FUNDS TO THE DEPARTMENT TO REIMBURSE SCHOOL DISTRICTS AND PUBLIC SCHOOL ACADEMIES THAT OFFER PUPILS THE OPPORTUNITY TO TAKE AN ASSESSMENT DESCRIBED UNDER SUBSECTION (1). BY JUNE 1, 2020, AND BY JUNE 1 OF EACH YEAR THEREAFTER, THE DEPARTMENT SHALL SUBMIT A REPORT TO THE LEGISLATURE THAT INCLUDES BOTH OF THE FOLLOWING:
(A) THE NUMBER OF SCHOOL DISTRICTS AND PUBLIC SCHOOL ACADEMIES THAT OFFERED PUPILS THE OPPORTUNITY TO TAKE AN ASSESSMENT DESCRIBED UNDER SUBSECTION (1) DURING THE IMMEDIATELY PRECEDING SCHOOL YEAR.
(B) THE NUMBER OF PUPILS WHO TOOK AN ASSESSMENT DESCRIBED UNDER SUBSECTION (1) DURING THE IMMEDIATELY PRECEDING SCHOOL YEAR."
