The House Standing Committee on Ways and Means was called to order by Chair Iden.

HB 4208 (Rep. Johnson) A bill to amend 1976 PA 451, entitled "The

revised school code, "by amending section 1249 (MCL

380.1249), as amended by 2018 PA 235.

The Chair laid HB 4335 before the committee:

HB 4335

(Rep. Yaroch) A bill to amend 1980 PA 299, entitled "Occupational code, "by amending sections 1110 and 1205 (MCL 339.1110 and 339.1205), section 1110 as amended by 2014 PA 137 and section 1205 as amended by 1997 PA 97.

Representative Yaroch and Sam Boumis testified in support of HB 4335.

Scott Weaver representing Douglas J. Aveda, testified in support of HB 4335.
