COMMITTEE MEETING MINUTES

Thursday, September 29, 2022 10:30 AM Room 352, House Appropriations, State Capitol Building

The House Committee on Rules and Competitiveness was called to order by Chair Calley.

The Chair laid SB 712 before the committee:

SB 712 (Sen. MacDonald)

A bill to amend 1956 PA 218, entitled "The insurance code of 1956," by amending section 8182 (MCL 500.8182), as added by 1990 PA 1, and by adding sections 8199b and 8199c.

A bill to amend 1969 PA 317, entitled "Worker's disability compensation act of 1969," by amending

section 405 (MCL 418.405), as amended by 2021 PA 129.

The Chair laid before the committee a preview presentation from the House School Safety Task Force.
