**Overview**

The Department of State Police provides a wide range of law enforcement services—including highway patrol, criminal investigations, forensic sciences, motor carrier enforcement, emergency management, highway safety planning, fire investigation, criminal justice data processing, and various specialized law enforcement services. The Department's responsibilities also include oversight of law enforcement standards in the state through the Michigan Commission on Law Enforcement Standards (MCOLES) and administration of several law enforcement-related grant programs.

**Sec. 207. Expenditures Posted On A Publicly Accessible Internet Website - NEW**

House Subcommittee adds new language directing the department to develop a publicly accessible website and to post each expenditure made by the department.

**Sec. 202. Appropriations Subject To The Management and Budget Act - MAINTAINED**

Exec. Rec. deletes authorizations under this act being subject to the Management and Budget Act. House Subcommittee maintains current year language.

**Sec. 203. Definitions – MODIFIED**

Exec. Rec. deletes several acronyms and definitions used within the current law. House Subcommittee maintains current year language but deletes the ARRA definition/acronym.

**Sec. 204. Civil Service 1% Charge - MAINTAINED**

Exec. Rec. deletes authorizing Civil Service to charge departments 1% for administrative purposes. House Subcommittee maintains current year language with a slight non-policy changing modification.

**Sec. 205. Civil Service Hiring Freeze – MAINTAINED**

Exec. Rec. deletes a hiring freeze requirement on the state classified civil service, with the exception of authorization from the state budget director. House Subcommittee maintained current year language.

**Sec. 207. Privatization Plans – MAINTAINED**

Exec. Rec. deletes 60 day requirement for submitting a privatization plan to the appropriations subcommittees and the fiscal agencies. House Subcommittee maintains current year language but renumbers to Sec. 223.

**Sec. 208. Department Reports On The Internet - MAINTAINED**

Exec. Rec. deletes requiring the Department to post reports on the Internet. House Subcommittee maintains current year language.

**Sec. 209. Purchase of Foreign Goods and Services - MAINTAINED**

Exec. Rec. deletes requirement that funds not be used for foreign goods or services if comparable American goods and services are available. House Subcommittee maintains current year language.

**Sec. 210. Deprived And Depressed Communities - MAINTAINED**

Exec. Rec. deletes requiring departments to allow businesses in deprived and depressed communities to compete for contracts and other services. House Subcommittee maintains current year language with slight non-policy changing modifications.

**Sec. 211. Employee Expenses Reimbursement – DELETED**

Exec. Rec. deletes legislative intent for allowing department personnel to request eligible reimbursement expenses related to department operations. House Subcommittee concurs with Exec. Rec.

**Sec. 213. Contractual Services Subsidy – MAINTAINED**

Exec. Rec. deletes legislative intent for not allowing the department to provide a subsidy for contractual services it provides. House Subcommittee maintains current year language.

**Sec. 214. Report and Records Retention – MAINTAINED**

Exec. Rec. deletes requirement for department to retain copies of all reports funded under appropriations in part 1. House Subcommittee maintains language with slight non-policy changing modifications.

**Sec. 215. Casino Gaming Oversight Report - MAINTAINED**

Exec. Rec. deletes the Department's annual reporting of casino gaming oversight activities. House Subcommittee maintains current year language.

**Sec. 216. State Accident Data Collection - MODIFIED**

Exec. Rec. modifies language requiring entering vehicle identification numbers into a state accident data collection system and making the information available at a reasonable cost. Renumbered as Sec. 16-203 in the Exec. Rec. House Subcommittee concurs with Exec. Rec. and numbers as Sec. 218.

**Sec. 217. School Violence Hotline - DELETED**

Exec. Rec. deletes requirement for the Department to maintain a school violence hotline. House Subcommittee concurs with Exec. Rec.

**Sec. 218. At-Post Troopers - MODIFIED**

Exec. Rec. deletes requiring that appropriations designated for At-Post Troopers only be spent on direct trooper costs; deletes legislative intent for maintaining a minimum trooper strength of 1,075 and for a required quarterly trooper strength report. House Subcommittee maintains current year language but modifies subsection (2) basing the At-Post Trooper strength on the most recent Resource Allocation Model (RAM).

**Sec. 219. Post Closure Notification - MODIFIED**

Exec. Rec. deletes requirement for the Department to provide a 180-day notification of planned post closures or consolidations. House Subcommittee maintains current year language but changes the 180 day notification to 90 days.

**Sec. 220. General Law Enforcement Assistance to Communities - MAINTAINED**

Exec. Rec. deletes requirement for the Department to provide general law enforcement services to communities without local law enforcement services. House Subcommittee maintains current year language.

**Sec. 221. Marshall Post Replacement - MODIFIED**

Exec. Rec. deletes allowing the Department to enter into an agreement with Calhoun County to build a new post in Marshall. House Subcommittee maintains current year language but changes the location of the post to Region 4 of District 5 as identified by the department.

**Sec. 223. Out of State Travel - MAINTAINED**

Exec. Rec. deletes limiting out of state travel for employees and other travel related regulations. House Subcommittee maintains current year language.

**Sec. 224. Employee Disciplinary Action - MAINTAINED**

Exec. Rec. deletes requirement for the Department not to take disciplinary action for an employee that communicates with the Legislature or legislative staff. House Subcommittee maintains current year language.

**Sec. 226. Interoperable Communications Plans - MAINTAINED**

Exec. Rec. deletes requirement for the Department to encourage regional tactical interoperable communications plans between all levels of government agencies. House Subcommittee maintains current year language.

**Sec. 232. Recruitment of MCOLES Certified Police Officers for Trooper Schools - MAINTAINED**

Exec. Rec. deletes placing emphasis on MCOLES certified police officers for trooper schools. House Subcommittee maintains current year language.

**Sec. 234. Attorney General Legal Services - MAINTAINED**

Exec. Rec. deletes using funds to pay for legal services that are the responsibility of the Attorney General. House Subcommittee maintains current year language.

**Sec. 235. Special Operations and Events Spending Plans - DELETED**

Exec. Rec. deletes restrictions for using funds appropriated for Post Uniform Services and Forensic Sciences for Special Operations and Events. House Subcommittee concurs with Exec. Rec.

**Sec. 238. Building Operations and Leasing Costs - DELETED**

Exec. Rec. deletes requirement for the Department to work with DMB to reduce building operations and leasing costs for all of the Departments facilities. House Subcommittee concurs with Exec. Rec.

**Sec. 239. Michigan International Speedway Traffic Control - DELETED**

Exec. Rec. deletes legislative intent for using any available funds for traffic control purposes at the Michigan International Speedway. House Subcommittee concurs with Exec. Rec.

**Sec. 241. \$1.8 Million Federal IDG to Judiciary - MODIFIED**

House Subcommittee adds language basing the amount of the IDG on the availability of federal funds.

**Sec. 242. GF/GP Lapse Report – MODIFIED**

Exec. Rec. deletes requiring an end-of-year GF/GP lapse report by the Department. House Subcommittee maintains current year language but modifies the date.

**Sec. 245. LEIN System/DHS Bridges System Coordination – MAINTAINED**

Exec. Rec. deletes requiring coordination between the LEIN system and the Bridges case management system in DHS. House Subcommittee maintains current year language.

**Sec. 253. Transparency of Funds Expended – DELETED**

Exec. Rec. deletes requiring the posting of expenditures on a publicly accessible website. House Subcommittee concurs with Exec. Rec.

**Sec. 254. FTE Report – DELETED**

Exec. Rec. deletes requiring the department to submit a bimonthly report to the appropriations subcommittees and the fiscal agencies concerning the number of FTEs in pay status by Civil Service classification. House Subcommittee concurs with Exec. Rec.

**Sec. 301. LEIN User Fees Waiver - DELETED**

Exec. Rec. deletes waiving LEIN user fees for FY11 if an agency does not have an outstanding LEIN balance in previous years. House Subcommittee concurs with Exec. Rec.

**Sec. 302. Department of Technology, Management and Budget User Fees - DELETED**

Exec. Rec. deletes requiring departments from paying user fees for information technology services. House Subcommittee concurs with Exec. Rec.

**Sec. 303. Work Projects for Information Technology - DELETED**

Exec. Rec. deletes allowing technology projects as work projects. House Subcommittee concurs with Exec. Rec.

**Sec. 304. LEIN Departmental Policies Report - MAINTAINED**

Exec. Rec. deletes requirement to use funds for a report detailing the Department's LEIN policies. House Subcommittee maintains current year language.

**Sec. 305. Unauthorized Use of the LEIN System - DELETED**

Exec. Rec. deletes encouraging law enforcement agencies with finding ways to discourage possible abuse of the LEIN system. House Subcommittee concurs with Exec. Rec.

**Sec. 306. LEIN System Probation Information - DELETED**

Exec. Rec. deletes requiring the creation of procedures for entering probation related information on the LEIN system. House Subcommittee concurs with Exec. Rec.

**Sec. 307. MPSCS Use By Local Police Agencies - DELETED**

Exec. Rec. deletes requiring the Department acting as a liaison between DIT and local public safety agencies to facilitate the use of the MPSCS. House Subcommittee concurs with Exec. Rec.

**Sec. 308. LEIN Fee Increase - DELETED**

Exec. Rec. deletes requiring the Department to report any LEIN fee increases to the Legislature 60 days prior to the effective date of the increase. House Subcommittee concurs with Exec. Rec.

**Sec. 309. *Electronic Real Time Auto Insurance System* - DELETED**

Exec. Rec. deletes allowing the Department to develop an electronic real time auto insurance enforcement system. House Subcommittee concurs with Exec. Rec.

**Sec. 310. *MPSCS Expansion For More Local Users* – MODIFIED**

Exec. Rec. deletes legislative intent for expansion of the MPSCS to allow more local users on the system. House Subcommittee maintains current year language but replaces local users with private users with the intent for generating revenue.

**Sec. 401. *Secondary Road Patrol Program Report* - MAINTAINED**

Exec. Rec. deletes requirement for biannual reports concerning the Secondary Road Patrol Program. House Subcommittee maintains current year language.

**Sec. 501. *DNA Analysis Samples and Records* - MAINTAINED**

Exec. Rec. deletes notifying police agencies when changes are made to the Department's DNA analysis samples and records retention protocol. House Subcommittee maintains current year language.

**Sec. 502. *Emergency Treatment of Sexual Assault Victims Procedures* - MAINTAINED**

Exec. Rec. deletes requiring the Department to work with various health organizations to ensure that standard procedures are followed in collecting evidence for emergency treatment of sexual assault victims. House Subcommittee maintains current year language.

**Sec. 601. *MCOLES Reimbursement Distribution* - DELETED**

Exec. Rec. deletes requiring reimbursement of MCOLES funds upon certification by MCOLES. House Subcommittee concurs with Exec. Rec.

**Sec. 603. *Mental Health Awareness Training* - MAINTAINED**

Exec. Rec. deletes requiring that the appropriations for mental health awareness training be used for training law enforcement and other personnel with people experiencing mental disorders or mental illness. House Subcommittee maintains current year language.

**Sec. 604. *MCOLES Certification For Motor Carrier Officers and Capitol Security Officers* - DELETED**

Exec. Rec. deletes allowing MCOLES funds to provide training for MCOLES certification for motor carrier officers and Capitol security officers. House Subcommittee concurs with Exec. Rec.

**Sec. 803. *Homeland Security Grant Restrictions* - DELETED**

Exec. Rec. deletes restricting Homeland Security funds for first responders and the City of Detroit. House Subcommittee concurs with Exec. Rec.

**Sec. 902. *Security Guards* – MAINTAINED**

Exec. Rec. deletes requiring the expenditure of security services only for the Capitol Building. House Subcommittee maintains current year language.

**Sec. 1002. *Private Donations* - MAINTAINED**

Exec. Rec. deletes legislative intent that private donation not supplant general fund appropriations. House Subcommittee maintains current year language.

**Sec. 1101. *State Police Services Near Prisons* - DELETED**

Exec. Rec. deletes ensuring that no downgrades in State Police services are experienced in the vicinity of state prisons. House Subcommittee concurs with Exec. Rec.

**Sec. 1102. *Methamphetamine Reports* - DELETED**

Exec. Rec. deletes reporting requirement for methamphetamine related criminal activities. House Subcommittee concurs with Exec. Rec.

**Sec. 1201. *School Bus Inspections* - MODIFIED**

Exec. Rec. deletes reporting requirement for the Department's school bus inspections. House Subcommittee modifies reporting requirement for school districts with at least two year of chronic problems with their inspections.
