SUMMARY OF HIGHER EDUCATION APPROPRIATION ISSUES

FY 2003-04

Table 1 lists the FY 2003-04 enacted appropriations. Tables 2, 3, and 4 outline the FY 2003-04 recommendations of the Governor, House, and Senate, respectively. A summary of the FY 2003-04 issues is provided below.

A. PER-STUDENT FLOOR FUNDING

The Governor retained the current-year grouping of the 15 public universities into four separate tiers, each with a different per-student funding floor, but she did not allocate funds based on those groupings. The House retained the current-year grouping of the 15 public universities into four separate tiers and allocated funding reductions by taking into account the relative funding levels within the groupings. The reductions ranged from 5.45% to 6.74%. The Senate bill discarded the tier structure and incorporated a \$4,000 per-student funding floor for all universities.

The Conference Report discarded the four per-FYES funding floors, identified a single funding floor of \$3,890 per FYES, and provided an additional \$9.5 million in floor-funding support for university operations in FY 2003-04.

B. UNIVERSITY OPERATIONS

Due to Michigan's economic situation, the Executive budget provided for an across-the-board reduction of 6.74% of year-to-date FY 2002-03 appropriations. The House provided an average reduction of 6.5%, with a range of 5.45% to 6.74% reductions. The Senate included \$23 million in Merit Award Trust Fund monies to support base university operations. It also allocated \$10 million in base funding for Western Michigan University to support a life sciences research and commercialization center. This approach resulted in an average reduction of 4.6%, with a range of funding from a 15.9% increase for Grand Valley State University to reductions of 6.7% for the three major research universities (Michigan State, University of Michigan at Ann Arbor, and Wayne State).

The Conference Committee included \$9.5 million in Merit Trust Fund monies as floor funding to support four universities (CMU, GVSU, OU, and SVSU). See Table 1, column 4, for the amount for each institution. It also appropriated a supplemental \$7 million for FY 2002-03 university operations for 12 of the 15 universities from the Merit Trust Fund. Table 5 displays the amounts of the FY 2002-03 supplemental appropriation to each university.

C. FINANCIAL AID PROGRAMS

The Executive proposed elimination of seven financial aid and grant programs and the creation of a new Michigan Opportunity Scholarships program, which would absorb nearly all of the funding currently directed to five of the seven programs proposed for termination. The House did not concur with the Governor, but it did eliminate three programs (Adult Part-time, General Degree Reimbursement, and Allied Health Degree Reimbursement) and reallocated most of those funds to the State Competitive Scholarship, the Tuition Grant, and the Michigan Work Study programs. The Senate retained all of the current-year programs, reduced them by 6.74%, and then added \$100,000 to the General Degree Reimbursement program for infrastructure and technology needs at independent colleges and universities.

The Conference Report deleted the General and Allied Health degree reimbursement programs and reallocated that funding to the competitive scholarship and tuition grant line items.

D. MERIT AWARDS

The Executive proposed funding for this program at \$65.1 million to support awards for graduating high-school seniors from the classes of 2000 through 2003 who achieved qualifying scores. Awards for recipients from the class of 2004 would be funded in the FY05 budget, and the awards would be reduced to \$500 beginning with that graduation class. The House did not concur but added \$60 million to support the payment of the first installment of the Class of 2004 awards at \$2,500 each. The Senate concurred with the House but added \$70 million.

The Conference Report added about \$65 million to the Executive recommendation for this line item for the first half of payments for the class of 2004 Award recipients.

E. STATE AND REGIONAL PROGRAMS

The Executive, House, Senate, and Conference Report eliminated the one-time funding for the Rare Isotope Accelerator project at Michigan State University.

The Governor recommended elimination of funding for the Japan Center. The House reduced funding to \$150,000, while the Senate concurred with the Executive. The Conference Report did not contain funding for that program. Likewise, the Governor recommended elimination of funding for the Midwest Higher Education Compact. The House included funding at \$82,500, while the Senate reduced it to \$100. The Conference Report included funding at \$82,500, which the Governor vetoed.

The Governor, House, Senate, and Conference Report reduced funding for the Agricultural Experiment Station (AES) and the Cooperative Extension Service (CES). All retained funding for Project GREEN in its current-year allocation proportion between AES and CES. The program absorbed the 6.7% reduction that was common for many programs.

F. TUITION RESTRAINT LANGUAGE

The Governor included tuition restraint language that specified the intent to have “reasonable” increases in resident undergraduate tuition and fees. The House, Senate, and Conference Report concurred with the Governor.

G. KING - CHAVEZ - PARKS (KCP) PROGRAMS

The Governor's budget included a 6.74% reduction for each of the component sections of the KCP programs. The House concurred. The Senate added \$300 to the House level, and the Conference Report concurred with the Governor and House amounts. Tables 7A and 7B provide the line-item detail for all six of the King - Chavez - Parks programs.

H. TUITION INCENTIVE PROGRAM (TIP)

The Tuition Incentive Program provides an incentive to low-income middle and high school students to complete high school and continue on to college by pledging to pay their tuition and fees for associate degree or certificate programs, as well as up to \$2,000 at four-year institutions, if they complete high school. The Governor recommended an additional \$4 million for TIP. The House did not concur but used the recommended \$4 million to support the State Competitive Scholarship program. The Senate concurred with the Governor's funding level.

The Conference Report concurred with the Governor's funding recommendation.

I. INDIAN TUITION WAIVERS

Funding for Indian Tuition Waivers continues as a part of the base appropriation for each university. Table 8 lists the amounts that were added to the base in FY 1996-97 and continued since then.

J. CAPITAL OUTLAY

For informational purposes only, Table 9 lists the capital outlay projects for Michigan's public universities that have been authorized since 1992.

K. BOILERPLATE ISSUES

1. **University Groupings for Floor Funding** (former Sec. 409). The Conference Report does not contain any reference to groupings for funding floors; that language had been included in previous appropriation bills.
2. **General Degree Reimbursement Program** (Sec. 304). The Conference Report eliminates the language, since there are no appropriations for FY 2003-04 for this program.
3. **Allied Health Degree Reimbursement Program** (Sec. 305). The Conference Committee adopted the House proposal to eliminate the language, since funding has been eliminated for the program.
4. **Tuition Incentive Plan** (Sec. 310). The Conference Report does not include Executive-proposed language terminating the application process as of September 30, 2003.
5. **Provision of required book lists** (Sec. 426). The Conference Committee adopted the Senate-passed language concerning a report from the Presidents Council regarding group purchasing of textbooks used by students at the fifteen state universities.
6. **Legislative intent language concerning MPSERS contribution rate** (Sec. 437). The Conference Committee included the Senate-proposed language regarding the Michigan Public School Employee Retirement System (MPSERS) contribution rate for seven universities.

7. **FY 2002-03 fund source shift** (Sec. 1101). The Conference Report included the Senate-proposed language that switched the fund source for the FY 2002-03 supplemental enacted in December 2002 from the Merit Award Trust Fund to the Tobacco Settlement Trust Fund.
8. **Legislative intent language concerning notification of financial aid recipients** (Sec. 1102). The Conference Committee added the Senate-proposed language concerning notification of competitive scholarship and tuition grant award recipients by July 31, 2003.

L. FY 2002-03 SUPPLEMENTALS

Public Act 144 of 2003 appropriated \$7 million to twelve state universities. See [Table 5](#) for the figures.

Public Act 173 of 2003 appropriated \$3.4 million for the Tuition Incentive Program (TIP) to support increased retention of students and additional costs.
