26 Sec. 201. Pursuant to section 30 of article IX of the state
 27 constitution of 1963, total state spending from state sources under
 28 part 1 for fiscal year 2021-2022 is \$111,392,300.00 and state
 29 spending from state sources to be paid to local units of government



1 for fiscal year 2021-2022 is \$8,880,300.00. The itemized statement
 2 below identifies appropriations from which spending to local units
 3 of government will occur:

20 Sec. 202. The appropriations authorized under this part and
 21 part 1 are subject to the management and budget act, 1984 PA 431,
 22 MCL 18.1101 to 18.1594.

23 Sec. 203. As used in this part and part 1:

24 (a) "Department" means the department of environment, Great
 25 Lakes, and energy.

26 (b) "Director" means the director of the department.

27 (c) "FTE" means full-time equated.

28 (d) "IDG" means interdepartmental grant.

29 (e) "NPDES" means national pollution discharge elimination



1 system.

2 Sec. 204. The departments and agencies receiving
3 appropriations in part 1 shall use the internet to fulfill the
4 reporting requirements of this part. This requirement shall include
5 transmission of reports via email to the recipients identified for
6 each reporting requirement and it shall include placement of
7 reports on an internet site.

8 Sec. 205. Funds appropriated in part 1 shall not be used for
9 the purchase of foreign goods or services, or both, if
10 competitively priced and of comparable quality American goods or
11 services, or both, are available. Preference shall be given to
12 goods or services, or both, manufactured or provided by Michigan
13 businesses, if they are competitively priced and of comparable
14 quality. In addition, preference shall be given to goods or
15 services, or both, that are manufactured or provided by Michigan
16 businesses owned and operated by veterans, if they are
17 competitively priced and of comparable quality.

18 Sec. 206. The department shall not take disciplinary action
19 against an employee of the department or departmental agency in the
20 state classified civil service because the employee communicates
21 with a member of the senate or house or a member's staff, unless
22 the communication is prohibited by law and the department or agency
23 taking disciplinary action is exercising its authority as provided
24 by law.

25 Sec. 207. Consistent with section 217 of the management and
26 budget act, 1984 PA 431, MCL 18.1217, the departments and agencies
27 receiving appropriations in part 1 shall prepare a report on out-
28 of-state travel expenses not later than January 1 of each year. The
29 travel report shall be a listing of all travel by classified and



1 unclassified employees outside this state in the immediately
2 preceding fiscal year that was funded in whole or in part with
3 funds appropriated under this part and part 1. The report shall be
4 submitted to the senate and house appropriations committees, the
5 senate and house fiscal agencies, and the state budget director.
6 The report shall include the following information:

7 (a) The dates of each travel occurrence.

8 (b) The transportation and related costs of each travel
9 occurrence, including the proportion funded with state general
10 fund/general purpose revenues, the proportion funded with state
11 restricted revenues, the proportion funded with federal revenues,
12 and the proportion funded with other revenues.

13 Sec. 208. Funds appropriated in part 1 shall not be used by a
14 principal executive of the department, state agency, or authority
15 to hire a person to provide legal services that are the
16 responsibility of the attorney general. This prohibition does not
17 apply to legal services for bonding activities and for those
18 outside services that the attorney general authorizes.

19 Sec. 209. Not later than November 30, the state budget office
20 shall prepare and transmit a report that provides for estimates of
21 the total general fund/general purpose appropriation lapses at the
22 close of the prior fiscal year. This report shall summarize the
23 projected year-end general fund/general purpose appropriation
24 lapses by major departmental program or program areas. The report
25 shall be transmitted to the chairs of the senate and house
26 appropriations committees and the senate and house fiscal agencies.

27 Sec. 210. In addition to the funds appropriated in part 1,
28 there is appropriated an amount not to exceed \$3,000,000.00 for
29 state restricted contingency authorization. These funds are not



1 available for expenditure until they have been transferred to
2 another line item in part 1 under section 393(2) of the management
3 and budget act, 1984 PA 431, MCL 18.1393.

4 Sec. 211. From the funds appropriated in part 1, the
5 department shall provide to the department of technology,
6 management, and budget information sufficient to maintain a
7 searchable website accessible by the public at no cost that
8 includes, but is not limited to, all of the following for the
9 department or agency:

10 (a) Fiscal year-to-date expenditures by category.

11 (b) Fiscal year-to-date expenditures by appropriation unit.

12 (c) Fiscal year-to-date payments to a selected vendor,
13 including the vendor name, payment date, payment amount, and
14 payment description.

15 (d) The number of active department employees by job
16 classification.

17 (e) Job specifications and wage rates.

18 Sec. 212. Within 14 days after the release of the executive
19 budget recommendation, the department shall provide to the state
20 budget office information sufficient to provide the senate and
21 house appropriations chairs, senate and house appropriations
22 subcommittees chairs, and the senate and house fiscal agencies with
23 an annual report on estimated state restricted fund balances, state
24 restricted fund projected revenues, and state restricted fund
25 expenditures for the fiscal years ending September 30, 2021 and
26 September 30, 2022.

27 Sec. 213. The department shall maintain, on a publicly
28 accessible website, a department scorecard that identifies, tracks,
29 and regularly updates key metrics that are used to monitor and



1 improve the department's performance.

2 Sec. 214. Total authorized appropriations from all sources
3 under part 1 for legacy costs for the fiscal year ending September
4 30, 2022 are estimated at \$33,648,000.00. From this amount, total
5 department appropriations for pension-related legacy costs are
6 estimated at \$18,851,400.00. Total department appropriations for
7 retiree health care legacy costs are estimated at \$14,796,600.00.

8 Sec. 215. To the extent permissible under the management and
9 budget act, 1984 PA 431, MCL 18.1101 to 18.1594, the director shall
10 take all reasonable steps to ensure businesses in deprived and
11 depressed communities compete for and perform contracts to provide
12 services or supplies, or both. The director shall strongly
13 encourage firms with which the department contracts to subcontract
14 with certified businesses in depressed and deprived communities for
15 services, supplies, or both.

16 Sec. 216. (1) On a quarterly basis, the department shall
17 report to the senate and house appropriations committees, the
18 senate and house appropriations subcommittees on the department
19 budget, and the senate and house fiscal agencies the following
20 information:

21 (a) The number of FTEs in pay status by type of staff and
22 civil service classification.

23 (b) A comparison by line item of the number of FTEs authorized
24 from funds appropriated in part 1 to the actual number of FTEs
25 employed by the department at the end of the reporting period.

26 (2) By April 1 of the current fiscal year and semiannually
27 thereafter, the department shall report to the senate and house
28 appropriations committees, the senate and house appropriations
29 subcommittees on the department budget, and the senate and house



1 fiscal agencies the following information:

2 (a) Number of employees that were engaged in remote work in
3 2021.

4 (b) Number of employees authorized to work remotely and the
5 actual number of those working remotely in the current reporting
6 period.

7 (c) Estimated net cost savings achieved by remote work.

8 (d) Reduced use of office space associated with remote work.

9 Sec. 217. Appropriations in part 1 shall, to the extent
10 possible, not be expended by the department until all existing work
11 project authorizations available for the same purposes are
12 exhausted.

13 Sec. 218. If the state administrative board, acting under
14 section 3 of 1921 PA 2, MCL 17.3, transfers funds from an amount
15 appropriated under this part and part 1, the legislature may, by a
16 concurrent resolution adopted by a majority of the members elected
17 to and serving in each house, intertransfer funds within this part
18 and part 1 for the particular department, board, commission,
19 officer, or institution.

20 Sec. 219. The departments and agencies receiving
21 appropriations in part 1 shall receive and retain copies of all
22 reports funded from appropriations in part 1. Federal and state
23 guidelines for short-term and long-term retention of records shall
24 be followed. The department may electronically retain copies of
25 reports unless otherwise required by federal and state guidelines.

26 Sec. 220. The department shall report no later than April 1 on
27 each specific policy change made to implement a public act
28 affecting the department that took effect during the prior calendar
29 year to the senate and house appropriations committees, the senate



1 and house subcommittees on the department budget, the joint

24 petroleum product cleanup program, and the environmental protection
25 bond projects under section 19508(7) of the natural resources and
26 environmental protection act, 1994 PA 451, MCL 324.19508, to the
27 state budget director, the senate and house appropriations
28 subcommittees on the department budget, and the senate and house
29 fiscal agencies:

19 (4) Unexpended and unencumbered amounts remaining from
20 appropriations from the refined petroleum fund activities contained
21 in 2007 PA 121, 2008 PA 247, 2009 PA 118, 2010 PA 189, 2011 PA 63,
22 2012 PA 200, 2013 PA 59, 2014 PA 252, 2015 PA 84, 2016 PA 268, 2017
23 PA 107, 2018 PA 207, 2019 PA 57, and 2020 PA 166 are appropriated
24 for expenditure for any site listed in this part and part 1 and any
25 site listed in the public acts referenced in this section.

26 (5) Unexpended and unencumbered amounts remaining from the
27 appropriations from the strategic water quality initiatives fund
28 contained in 2011 PA 50, 2011 PA 63, 2012 PA 200, 2013 PA 59, 2014
29 PA 252, 2015 PA 84, 2016 PA 268, 2017 PA 107, and 2018 PA 207 are



1 appropriated for expenditure for any site listed in this part and
2 part 1 and any site listed in the public acts referenced in this
3 section.

4 Sec. 224. Unexpended settlement revenues at the end of the
5 fiscal year may be carried forward into the settlement fund in the
6 succeeding fiscal year up to a maximum carryforward of
7 \$2,500,000.00.

8 Sec. 225.(1) From the funds appropriated in part 1, the
9 department shall do all of the following:

10 (a) Report to the house and senate appropriations committees,
11 the house and senate fiscal agencies, the house and senate policy
12 offices, and the state budget office any amounts of severance pay
13 for a department director, deputy director, or other high-ranking

 14 the Flint declaration of emergency response effort.
