Security Classification is the system used by the Department of Corrections to determine the appropriate security level of a prisoner. Generally, the prisoner’s institutional behavior, length of sentence, and escape potential determine the level. The higher the level, the more security risk a prisoner presents in terms of manageability or escape potential. Level I indicates minimum risk and easily managed. Level V indicates maximum risk, and maximum management problems, maximum security risk, or both.

¹Level I includes Special Alternative Incarceration program.

²Level III includes prisoners housed out of state under contract with the Virginia Department of Corrections in 1998 and 1999.

³Level V includes prisoners housed at the Michigan Youth Facility under contract with The GEO Group, Inc. in 1999 through 2004.

⁴Other Special Use beds include reception, administrative segregation, temporary segregation/holds, protective custody, detention, medical, infirmary, mental health, and dialysis.
